

**BY-LAW NO. 236**  
**A BY-LAW TO REGULATE THE USE OF PUBLIC PARKS**  
**WITHIN THE TOWN OF SACKVILLE**

THE COUNCIL OF THE TOWN OF SACKVILLE DULY ASSEMBLED, HEREBY ENACTS AS FOLLOWS:

INTERPRETATION

In this By-Law:

**“Motor Vehicle”** means every vehicle that is self-propelled, including the following: trucks, cars, motorcycles, mopeds, go-carts, minibikes, all-terrain vehicles and snowmobiles.

**“Parks”** means lands within the Town set aside for recreational and public use, including playgrounds and parks as per schedule “A”.

1. No person shall drive, ride or park a motor vehicle, snowmobile, bicycle, or horse in or upon a park within the Town of Sackville, except on such roadways and/or areas as designated for their use.
2. No person or corporation shall use a park or any part thereof for the purpose of holding or carrying on a fair, carnival, bazaar, or circus except with the permission of the Chief Administrative Officer and Department Head responsible or his/her designate.
3. No person shall pitch a tent, or park a trailer or recreational vehicle in a park without first obtaining approval in writing from the Chief Administrative Officer and Department Head responsible or his/her designate.
4. Any person who shall tamper with or injure any flowers, or any flower bed, vegetation, or any tree or shrub growing or being on such park or playground, or any bandstand, bench, or other article, or thing therein or thereon, or shall encumber, damage, injure, or foul any of the said public park or playgrounds or any part hereof in any manner whatsoever, shall be guilty of an offense and liable to a penalty under this by-law herein after mentioned.
5. No person shall loiter or remain in the parks between sunset and one hour before sunrise of the following day without approval in writing from the Chief Administrative Officer and Department Head responsible or his/her designate.
6. No person shall hold any public gatherings, meetings, or canteen outlet in a park without first obtaining approval in writing from the Chief Administrative Officer and Department Head responsible or his/her designate.

7. No person shall throw, drop or deposit, or cause to be deposited any glass bottle, glass, can, rubbish, refuse, waste paper, or waste of any kind in a park except in containers provided for that purpose.
8. No person shall light a fire in a park without the written permission of the Chief Administrative Officer and Department Head responsible or his/her designate.
9. No dog shall run loose in a park, dogs must be secured on a leash, any excrement from dog must be cleaned up immediately by the owner or owner designate.


PENALTY

10. Any person who violates any provision of this by-law is guilty of an offense punishable on Summary Conviction and liable to a fine or penalty of not less than one hundred dollars (\$100) for the first offense and not more than one thousand dollars (\$1,000) for any subsequent offense and in default of payment is liable to imprisonment in accordance with subsection 31(3) of the Summary Convictions Act.
11. By-Law No. 57, a By-Law pertaining to Lillas Fawcett Park is hereby repealed.
12. By-Law No. 162, A By-Law to Regulate the Use of Public Parks within the Town of Sackville is hereby repealed.
13. By-Law No. 162A, A By Law to Amend By-Law No. 162, A By-Law to Regulate the Use of Public Parks within the Town of Sackville is hereby repealed.
14. This By-Law comes into force on the date of the final passing thereof.
