

**BY-LAW NO. 245**  
**A BY-LAW FOR THE PRESERVATION OF ORDER**

The Council of the Town of Sackville enact as follows:

1. In this by-law:
  - a) “cargo” means all articles or material carried by a vehicle, including those used in the operation of the vehicle.
  - b) “town” means the Town of Sackville.
  - c) “town” property” shall include streets, sidewalks, lanes, pathways, and any other property owned or controlled by the Town of Sackville.
2. No person shall fight, bully, urinate or spit in public.
3. No person shall enter upon any school property unless authorized by law or by invitation to be upon said property.
4. a) No person shall, without written permission from the Commanding Officer of the local RCMP detachment or his designate, discharge:
  - i) a rim-fire rifle, a centre-fire rifle or a shotgun loaded with ball or slug within 400 meters of a dwelling, school, playground, athletic field, place of business, any street, or any public walking trail, or;
  - ii) a muzzle-loading firearm, a shotgun loaded with other than ball or slug or a bow charged with an arrow within 200 meters of a dwelling, school, playground, athletic field, place of business, any street, or any public walking trail, or;
  - iii) any air gun within 50 meters of a dwelling, school, playground, athletic field, place of business, any street, or any public walking trail.
  - b) The Commanding Officer of the local RCMP detachment before the issuance of written permission mentioned in subsection a) shall satisfy himself/herself that the area and method of firing will cause no danger to the public, that the person firing and/or in control of such firing is qualified to do such firing and/or supervision.
  - c) No person shall hunt on any land within the Town limits that is posted as a no hunting area by the Town of Sackville.
5. No unauthorized person shall carry any loaded firearm, air gun, BB gun, pellet gun or paint ball gun in any public place in Town.
6. No person shall coast or slide on a sled, toboggan, wagon or other device on any street in the Town.

7. a) No person shall put any type of material or any object on a public street or sidewalk in the Town.  
b) Cargo or material transported by a vehicle shall be contained, immobilized or secured so that it cannot leak, spill, blow off, fall from, fall through or otherwise be dislodged from the vehicle and fall onto Town property.
8. No person shall injure or destroy any tree or shrub planted along any of the streets or on any Town property.
9. a) No person shall remove, destroy, deface or damage any signboard or nameplate or any written or printed notice lawfully affixed or posted within the Town.  
b) No person shall staple, tape, nail, tack or affix in any way, any posters, ads, notices, signs or other items to the telephone, hydro or freestanding poles within the Town with the exception of approved postal collars as approved by the Town.
10. a) No person shall accost any other person on Town property with the object of canvassing or inducing such person to purchase goods or merchandise, nor for the purpose of inducing such persons to give or subscribe money for any purpose.  
b) Notwithstanding anything contained in this By-Law a person may solicit money for charitable and religious purposes if he has obtained permission from the Town Council authorizing such solicitation.
11. Any person who violates any of the provisions of this By-Law is guilty of an offense under Part II of the *Provincial Offences Procedure Act* as a category C offense.
12. Upon passing of this By-Law, By-Law No. 206 is hereby repealed.
13. This By-Law comes into effect on the date of final passing thereof.
