

**BY-LAW NO. 283**  
**A BY-LAW TO REGULATE THE USE OF PUBLIC PARKS**  
**WITHIN THE TOWN OF SACKVILLE**

Be it enacted by the Council of the Town of Sackville under the authority vested in it by the *Local Governance Act*, R.S.N.B., 2017, c. 18, as follows:

**DEFINITIONS**

1. In this By-Law:
  - (a) **“Chief Administrative Officer”** means the Chief Administrative Officer of the Town of Sackville.
  - (b) **“Department Head”** means a Department Head employed by the Town of Sackville and includes a Department Head’s designate who may be appointed from time to time.
  - (c) **“Motor Vehicle”** means every vehicle that is self-propelled, including trucks, cars, motorcycles, mopeds, go-carts, minibikes, all-terrain vehicles and snowmobiles.
  - (d) **“Park”** means any of the lands and premises within the Town of Sackville designated for recreational and public use and, for greater certainty, includes playgrounds and the parks listed in Schedule “A” attached hereto.

**GENERAL**

2. No person shall drive, ride or park a motor vehicle, snowmobile, bicycle or horse in or upon a Park within the Town of Sackville, except on such roadways and/or areas as designated for their use.
3. Without first obtaining approval in writing from the Chief Administrative Officer and the responsible Department Head:
  - (a) light a fire within a Park.
  - (b) use a Park, or any portion thereof, for the purpose of holding or carrying on a fair, carnival, bazaar, show, circus or operate a canteen outlet;
  - (c) pitch a tent, park a trailer or recreational vehicle in a Park;
  - (d) loiter or remain in a Park between sunset and one hour before sunrise of the following day; and
  - (e) hold any public gatherings or meetings within a Park.
4. No person shall tamper with or injure any flowers, or any flower bed, vegetation, or any tree or shrub growing or being on a Park, or any bandstand, bench, or other article, or thing therein or thereon, or shall damage, injure, or foul any Park or any part hereof in any manner whatsoever;

5. No person shall leave, throw, drop or deposit, or permit to be deposited any bottle, glass, can, rubbish, refuse, waste paper, waste or trash of any kind in a Park except into containers specifically provided for that purpose;
6. No person shall permit a dog to run loose in a Park. Dogs must be secured on a leash and any excrement from a dog must be cleaned up immediately by the owner or the person having conduct of the dog.
7. No person who has been personally served with a written notice by a representative of the Town of Sackville that they are either not permitted to enter or must leave a Park or Parks shall not enter or remain within the Park or Parks specified in the said written notice for the time period specified in the said written notice, which time period shall not exceed a period of one (1) year from the date the said written notice is served.

#### **ENFORCEMENT**

8. Any person who violates any provision of this By-Law and is guilty of an offence is liable on conviction to a fine or penalty of not less than One Hundred Dollars (\$100.00) for the first offence and not more than One Thousand Dollars (\$1,000.00) for any subsequent offence.

#### **REPEAL OF PREVIOUS BY-LAW**

9. By-Law No. 236, *A By-Law to Regulate the Use of Public Parks within the Town of Sackville* is hereby repealed.

#### **EFFECTIVE DATE**

10. This By-Law comes into force on the date of the final passing thereof.

Read a second time this 10<sup>th</sup> day of January, 2022.
