#### QUESTION PERIOD

Bruce Wark asked when the existing Lorne Street Phase III work will be complete. Director of Engineering & Public Works Jon Eppell responded that the anticipate finish would be mid-December, although could be pushed back, as the project is currently waiting on a specialized sub-contractor.

Bruce Wark asked if there is a difference in size of the current aboiteau and the proposed new aboiteau and if so, could the current one handle a one in one-hundred-year storm? Director of Engineering & Public Works Jon Eppell responded that once retention pond three (3) is connected to retention pond two (2), a storm like that could be handled. If required, the Municipality could deploy a portable pump system.

Bruce Wark asked why Sackville Fire & Rescue is called out to motor vehicle collisions on the highway. Sackville Fire & Rescue Chief Craig Bowser responded that response types for collision vary and could include fire, extrication, or assisting the RCMP with traffic.

Erica Butler asked if disconnecting water customers is a regular occurrence for the Municipality. Director of Financial Services Michael Beal responded that shut-off notification letters go out June/July, and that a sufficient payment arrangement must be made in order to maintain services, noting that if arrangements are not followed through, the water service will be disconnected. This is typically vacant properties.

Erica Butler asked about the plans for trails and usage, as it relates to the Kenridge Park Subdivision. Ms. Butler's question was referred to Plan360 for response.

Erica Butler asked if a plant at the Dorchester rink would be part of a long-range plan. Director of Active Living & Culture Matt Pryde responded that given our climate, the Municipality is preparing for the future in the event it is determined to include an ice plant. At this time, there are no official plans, however the surface would already be prepped, and the usage of the rink would continue as an outdoor rink.

Erica Butler asked why the lowest bid for Tender TAN-2023-11 Construction of the new Aboiteau AB-01 was significantly lower than others. Director of Engineering & Public Works Jon Eppell responded that bids factor in the time of year, the experience of the company with the scope of work and scheduling capabilities of the company.

Erica Butler asked if the work for the new aboiteau could be done over the winter. Director of Engineering & Public Works Jon Eppell responded that yes, the design of the project is intended to be done over the winter.
