









What is an Age-Friendly Community?

- An age-friendly community is designed to promote health, well-being and quality of life for older adults which contributes to the overall well-being of the entire community.
- One of its key components is the fact that the citizens help to identify what is needed in their communities and then provided the opportunity to create change.
- Age-friendly communities work from the ground up in an upstream manner. In addition, its more preventative in the long-term but also works to provide a better community for today.



Started by the World Health Organization and in collaboration with the Public Health Agency of Canada, age friendly communities were established in 2006.

The research and development of Age-Friendly Communities spans over three decades.





Brief descriptions of the 8 Domains

Civic Participation and Employment (e.g.,) Older adults should have opportunities to use their skills, knowledge, and time to contribute to society. There should be volunteerism, and employment opportunities, encouraging civic participation.

Transportation (e.g.,) It is accessible, safe, and affordable for all. There are available options so citizens who can not drive themselves can take part in social, cultural, volunteer, and recreational activities as well as carryout daily tasks such as shopping, going to appointments and work.

Community Support and Health Services (e.g.,) A wide range of accessible and affordable health services. Recognizing that access to quality health care is critical to ensure that older adults remain healthy and independent.

Respect and Social Inclusion (e.g.,) Respect and appreciation, social and economic inclusion for older adults. Older adults should be respected for there great deal of knowledge and experience as they are the backbone of our society. They are shown appreciation for their contributions in the community. They should feel included in social, political, and economic decisions and have intergenerational opportunities.

Social Participaction (e.g.,) The age-friendly approach makes it possible to support activities that bring people of all ages together and promotes the establishment of intergenerational opportunities to prevent social isolation. The opportunity to participate in family, community, cultural, economic, and political life making it possible to maintain ties, give meaning to life and promote feelings of belonging.

Outdoor Spaces and Buildings (e.g.,) They are well lit, accessible to all, a safe and secure environment, pavements and walkways are well maintained and accessible for everyone, safe pedestrian crossings, adequate rest areas and public washrooms.

Communication and Information (e.g.,) It's appropriate and age-friendly in distribution of information. The ability to stay connected with events, news, available services, and activities with timely, accessible, and practical information.

Housing (e.g.,) It is affordable, accessible, well-designed, safe, and a wide range of housing options with good connectivity to social services and the community.

Why and why now....



• In New Brunswick according to the 2021 census, 23% of the population was 65 years of age or older (approximately 178,000 people of the total 776,000 population).

This demographic is expected to grow, with the senior population projected to nearly *double* by 2040.

Urbanization has had a significant impact on New Brunswick over the past two years. It has posed challenges like housing shortages, environmental concerns, infrastructure and healthcare strains.

This emphasizes the growing need for Age-Friendly Communities in New Brunswick and why it is crucial at this pivotal time.



Here are the steps to be recognized as an Age-Friendly Community with reference to who completes each task


- Step 1: Government passes a resolution Mayor and Council
- Step 2: Establish an AFC Advisory Committee Citizens and other stakeholders with a recommendation to include a member of Council or municipal staff
- **Step 3**: Conduct an age friendly community assessment **AFC Committee**
- Step 4: Develop an action plan AFC Committee & they present it to council for review
- Step 5: Submit application to Seniors@gnb.ca to become recognized as an Age Friendly Community AFC Committee

Key roles for your Age-Friendly Community Committee, AFAC-NB, Mayor and Council

Your **Age-Friendly Community Advisory Committee** will work to create partnerships and collaborate fresh, creative thinking to discover solutions. They will advocate for your community and its citizens.

AFAC-NB is committed to supporting your AFC Committee in every possible way. Here are some examples of our contributions: A \$2,500. financial contribution for start-up costs. Community direct mail campaigns (some restrictions may apply), networking and educational opportunities for the AFC committee. In addition, supporting them through the application process & implementing the action plan.

Mayor & Council will embrace the age friendly model.

- The **Age Friendly Committee** will at the end of 5 years reapply to GNB to maintain their recognition status.
- Continued community engagement with citizens and relevant stakeholders with an emphasis on older adults.
- Share your success stories of completed actions so citizens know their being heard.



What the Gas Plant Threatens

• N.B. Power and Pro-Energy are proposing a 500MW gas plant situated in Centre Village, N.B, on the Chignecto Isthmus! This poses serious threats to many things, including:

Our Environment

- Greenhouse gas emissions (CO₂, methane)
- Destruction of wetlands, forests, ecosystems and waterways
- Disruption of the **Chignecto Isthmus**, a key ecological corridor

Our Health

- Air pollution →asthma and lung disease
- Higher risk for children, the elderly, and vulnerable groups
- Noise and light pollution affect quality of life



Our Rural Way of Life

- Productive farmland and homesteads at risk
- Falling property values
- Peaceful, natural community replaced with industry

Our Local Economy

- Damage to **small businesses** in both rural and **urban Sackville**
- Loss of eco-tourism, which relies on clean air, scenic beauty & quiet
- Decline in visitor appeal = less foot traffic, fewer customers



Environmental Risks

The proposed gas plant is not clean energy!

- Emits CO₂, NOx, and methane
- Accelerates climate change against national goals
- Damages biodiversity in rural ecosystems
- Raises risks of industrial accidents- we survive on a volunteer fire department, whereas Centre Village is 15 minutes away from the fire station!
- Tantramar must not become a fossil fuel corridor.

There is no "safe" distance for a plant of this size.





Subject: Willow Lane Closure

PROPOSAL

To close Willow Lane, Sackville from approximately 9:00am-3:00pm on Tuesday September 9th, 2025 to accommodate filming.

BACKGROUND

There is a film crew in town filming a movie/miniseries for Radio Canada International. They have requested a closure of Willow Lane from below the back of 19 Bridge Street (Ducks Aren't Real) to the sidewalk on Lorne Street to accommodate their filming. On consultation, both Sackville Fire and Public Works recommended closing the entirety of Willow Lane instead of a portion.

DISCUSSION

The closure of this portion of Willow Lane will only impede access to the back of some businesses on Bridge Street as well as Jean Coutu on Main St. Our Manager of Tourism and Business Development spoke to all of the affected businesses and the only ones that indicated they would have any issues were Jean Coutu and Tidewater books, who are both expecting deliveries that day. He then spoke to the film crew, who said they would allow the delivery trucks from those businesses to access the lane to make their deliveries.
